Admissions into Government ITIs / RITIs / MINORITY ITIS AND Private ITIS For August-2024 Session.

- Applications are invited from the eligible candidates for admissions into Government ITIs and Private ITIs in the State under NCVT pattern for August-2024 session.
- 2. The website address is https://iti.telangana.gov.in
- Qualification:- Person having educational qualification as 10th Pass / 8th pass can take admission in ITIs. The required minimum qualification is prescribed in the respective trade syllabus, as well as in the list of Trades under Craftsmen Training Scheme (CTS) given in the website.
- 4. The candidates who have already applied in 1st phase need not apply afresh in 2nd phase, but they shall get their original certificates verified, if not done earlier. Further they shall also submit options online through their respective logins.
- Age:- Candidates who have attained the age of 14 years as on the date of commencement of academic session i.e 1-8-2024 are eligible for admission. There is no upper age limit for candidates seeking admission in course under Craftsmen Training Scheme.
- 6. The interested candidates have to register themselves in the website and submit their applications through online along with web options in the order of preference of ITIs and Trades by paying Rs.100/- Application/verification fee through payment gateway link provided in the online application the verification of application shall be done online based on the document / certificates uploaded. Please visit the website for the details of, Prospectus, Seats Availability, notifications, and guidelines issued from time to time. Seats will be allotted to the candidates whose application has been verified online and approved.
- 7. Those Candidates who have applied earlier can submit the options, without paying Application Verification fees.
- 8. All the Original Certificates shall be scanned and uploaded in the website.
- Seats will be allotted based on the merit, rule of reservation and the web options given by the candidate. The selected candidates will be informed through SMS to the Registered Mobile number about the seat allotment with instructions to report at the concerned ITI.
- 10. Single online application is adequate to apply for admissions into any of the Government and Private I.T.I.s in Telangana State. Candidates are advised to give more number of options to get the seat. Physical form of application will not be entertained.
- 11. All the admissions are subject to clarifications / Instructions issued by State Government and DGT, New Delhi from time to time.
- 10 All the Applicants are informed that the Mobile number, Mail ID, & Aadhar number are mandatory columns. Before applying ensure that the names &Date of Birth in Aadhar card should be as per the SSC memo. The Mobile number provided in the application should not be changed till completion of I.T.I, course if seat allotted. Any change in mobile number, the admission is liable to be cancelled at any instance during the process of admissions.
- 11 Bonafied, Study, Nativity/local, Divyang and Community/cast Certificates should have been issued by Government of Telangana, otherwise the Candidates shall be treated as Non-local.
