## NOTIFICATION CALLING FOR APPLICATIONS FROM THE ELIGIBLE CANDIDATES TO APPEAR AS PRIVATE CANDIDATE IN THE AITT UNDER (CTS)

- 1. Applications are invited from the eligible interested candidates to appear as Private Candidates in the AITT under CTS for award of NTC have been categorized based on their educational background and experience.
- 2. Eligibility criteria for Trainees: The Candidates who have interested to appear as 'Private Candidates' will be admitted under one of the following categories:

#### I. Category-I: Ex-trainees (successful pass-outs) of ITI:

A. Ex-trainees of ITI who already possess NTC in one of the trades under CTS, are eligible for applying as Private candidate for an allied trade, provided he/ she fulfils all the conditions regarding educational qualification etc. Prescribed that allied trades.

B. In addition, the applicant should possess minimum of 1 year experience (as on date of submission of application) post the date of AITT result declaration in the desired allied trade in establishments implementing Apprenticeship Training Scheme (ATS)/ establishments registered under the Apprenticeship portal or registered MSMEs or Entities registered with any government/local authorities / shops covered under Factories Act 1948 and Shops and Establishments Act applicable for the concerned State.

## II. Category-II: Ex-trainees (successful pass-outs) and current trainees under CoE scheme:

A. The applicant should have the minimum prescribed entry qualification and should fulfill eligibility criteria for the desired trade under CTS, in which he/she intends to appear for AITT as Private Candidate mapping at CoE trades with that of regular CTS trades is provided in Annexure-IV- CoE Candidates must register as "Private Candidates" under CTS in the relevant /mapped CTS trades only.

B. There should be a minimum gap of 1 year between successful completions of CoE training i.e. from the date of result declaration to the date of submission of application for 'Private Candidate' certification.

C. During this gap of 1 year, the candidate must have undergone Industry training or gained experience in desired trade in establishments implementing Apprenticeship Training Scheme (ATS)/ establishments registered under the Apprenticeship portal or registered MSMEs or Entities registered with any government/local authorities / shops covered under Factories Act 1948 and Shops and Establishments Act applicable for the concerned State.

# III. Category III: SCVT Candidates ( admitted till August 2018 session )

- A. No special provisions have been made for SCVT Trainees to enroll as 'Private Candidates '. Going forward, SCVT trainees have been granted equivalence vide G.S.R 186 (E) dated 2<sup>nd</sup> March 2017 for undergoing apprenticeship training under the Apprentices Act 1961 to obtain 'NAC'.
- B. Only for SCVT trainees admitted till August 2018 batch, provision has been made for obtaining NTC by appearing in AITT under 'Private Candidates'. Such trainees will continue to be Government by old guidelines for 'Private Candidates'.

# IV. Category IV: other Candidates (Candidate not failing in any of the above 3 categories, including SCVT trainees enrolled from admission session 2019 onwards.

- A. The applicant should have the minimum prescribed entry qualification and should fulfill eligibility criteria for the relevant trade under CTS, in which he / she desires to appear for AITT as Private Candidates.
- B. Applicant should be minimum 21 years of age on the date of submission of application. There is no upper age limit.
- C. The applicant should possess minimum of 3 years experience ( on the date of submission of application ) in the relevant trade in establishments implementing Apprenticeship Training Scheme (ATS)/ establishments registered under the Apprenticeship portal or registered MSMEs or entities registered with any Government / Local Authorities / shops covered under Factories Act 1948 and shops and Establishment Act applicable for the concerned State.
- D. SCVT trainees enrolled from admission session 2019 and onwards may as 'Private Candidates' under this category i.e. Category IV, for obtaining NTC.
- 3. Age: Applicant should have minimum 21 years of age on the date of submission of application. There is no upper age limit.
